AMENDMENT NO. 8 TO NASPO MASTER AGREEMENT NO. MNNVP-140

THIS AMENDMENT is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), and IntelliFlash by DDN, Inc., 9351 Deering Avenue, Chatsworth, CA 91311 ("Contractor" or "Contract Vendor").

WHEREAS, the State has a Contract with the Contractor identified as NASPO Master Agreement No. MNNVP-140, April 1, 2015, through July 31, 2023 ("Contract"), to provide Computer Equipment, Peripherals & Related Services; and


This Amendment is effective upon the date that the final required signatures are obtained, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.




